

2. Notwithstanding anything contained therein, all permits issued under the principal Law shall be valid and effective and shall continue in force until the 31st day of December, 1932.

Permits under principal Law to be valid and effective and to continue in force.

3. This Law shall be deemed to have commenced and come into operation on the 1st day of January, 1932.

TO AMEND THE LAW RELATING TO CUSTOMS,

BE it enacted:—

1. This Law may be cited as the Customs, Excise and Revenue Law, 1932, and shall be read as one with the Customs, Excise and Revenue Law, 1899, (hereinafter referred to as the principal Law).

Short title.

2. The principal Law is hereby amended as follows:—

Amendment of principal Law.

(a) The words "or by regulations made under this Law" shall be inserted in section 10 after the words "this Law" (line two).

(b) The following section shall be inserted between section 21 and the expression "Wharfage Dues." :—

"Power to Governor in Council to make regulations.

21A.—(1) The Governor in Council may from time to time by Order make regulations with respect to all or any of the following matters:—

(a) The prescription of goods, wares or merchandise, imported into the Island and subsequently exported therefrom after modification thereof by local industry, on which drawback of duties of Customs shall be granted, paid or allowed;

(b) The conditions under which drawback of duties of Customs shall be granted, paid or allowed on such goods, wares or merchandise;

(c) The amount of such drawback;

(d) The maximum period during which such goods, wares or merchandise shall be exported ;

(e) The forms of declarations and other documents to be executed or used by the exporter and any other person before drawback is granted, paid or allowed on such goods, wares or merchandise.

(2) All regulations made under this section shall be published in the *Cyprus Gazette*, and shall thereupon have the like force and effect as if enacted herein, either immediately or on and from such other date as may therein or in that regard be provided.

(3) All regulations made under this section may from time to time be altered, amended or revoked in like manner by the Governor in Council."

Date of coming into operation and repeal.

3. This Law shall come into operation upon a date to be fixed by notice by the Governor in the *Cyprus Gazette* and thereupon the Customs, Excise and Revenue Law, 1928, section 4, shall be repealed.

TO AMEND THE CONSTRUCTION OF BUILDINGS, STREETS AND WELLS ON ARAZI MIRIE LAW, 1927.

BE it enacted:—

Short title.

1. This Law may be cited as the Construction of Buildings, Streets and Wells on Arazi Mirié (Amendment) Law, 1932, and shall be read as one with the Construction of Buildings, Streets and Wells on Arazi Mirié Law, 1927, (hereinafter called "the principal Law").

Amendment of section 11 (1) of Law 25 of 1927.

2. Section 11 (1) of the principal Law is hereby amended by the deletion of the proviso thereto.
